

[15] <u>Description of Equipment or protective system</u>

The Model MSHD3AA is a portable illumination device powered by three size "AA" alkaline cells. It consists of a battery pack, lamp assembly with 4 LEDs, head strap, and a coiled cord that connects the battery pack to the lamp assembly. The device is intended to be worn on a person's head.

Temperature range

The ambient temperature range is -20℃ to 40℃.

Electrical data

Three size "AA", 1.5 V, Energizer Part No. E91 or EN91 alkaline cells.

This device has exposed, isolated metal parts. The Measurement of Capacitance Test yielded a maximum capacitance of any exposed, isolated metal part of 4 pF (on the right nameplate screw). All other exposed, isolated metal parts had a measured capacitance of 3 pF or less.
